**Course Description:** An advanced course dealing with solid modeling. This course covers 3D drafting concepts and coordinate systems. Other topics include viewing, editing, dimensioning, and rendering objects.

- B. demonstrate competency in solid-modeling skills as applied to complex computer-aided design problems.
