**Course Title:** Paramedic Assessment and Review

**Course Description:**

This course is a comprehensive review of paramedic skill, knowledge and competencies; integrated lecture and laboratory instruction.

**Learning Outcomes:**

- A. At the end of this course, the paramedic student will demonstrate the knowledge, skill and ability to manage patients in the out of hospital environment by passing the program cognitive and psychomotor final exams and meeting all program clinical and field goals.

To achieve the learning outcomes, the student will

1. Demonstrate the ability to perform all of the skills in the NREMT Advanced Psychomotor exam.
2. Demonstrate the knowledge, skill and ability to assess and treat patients in the out of hospital arena.

**Course Requirements:** To earn a grade of “C” or higher the student must earn 70% of the total points for the course and meet all of the following course requirements.

- Attend 90% of all class sessions.
- Score a minimum of 33 on the Paramedic Program Affective Evaluation with no topic area receiving a score of 2 or less.
- Pass a comprehensive cognitive exam. You will be given 2 comprehensive written exams. You must pass one of them. If you do not pass either exam, you may be allowed one to take one additional exam provided that you have completed all of the preparatory assignments in this course.
- Pass the psychomotor exam.
- Meet all clinical and field internship goals.

**Course Grading Scale:**

- A- 90% or more of total possible points and met the Course Requirements
- B- 80% or more of total possible points and met the Course Requirements
- C- 70% or more of total possible points and met the Course Requirements
- D- 60% or more of total possible points and met the Course Requirements
- F- Less than 60% of total points possible and/or failed to meet the Course Requirements
