**Course Title:** Operations

**Course Prerequisites:** EMTP 202

**Textbooks:** Brady, Paramedic Care Principles and Practice Volume 5, 5th edition

**Course Description:**

Integrate knowledge of scene safety, personal safety, hazardous materials awareness, rescue awareness, ground ambulance operations, air ambulance operations and incident management techniques into scene operations and patient care. In order to register for EMTP 201-EMTP 215 student must have been selected for the program.

**Learning Outcomes:**

At the end of this course, the student will:

- A. At the end of this course, the paramedic student will be able to integrate knowledge of scene safety, personal safety, hazardous materials awareness, rescue awareness, ground ambulance operations, air ambulance operations and incident management techniques into scene operations and patient care.

To achieve the learning outcomes, the student will do the following.

1. Demonstrate the knowledge, skill and ability to document patient encounters and other work-related situations.
2. Explain the risks and responsibilities of operating an ambulance during an emergency response.
3. Establish and function with the incident management system.
4. Utilize a triage scheme to sort a group of simulated patients into appropriate categories.
5. Describe when it is appropriate to utilize air medical transport.
6. Explain how to prepare a patient and the scene for the arrival of air medical transport.
7. Describe the role of the paramedic during vehicle extrication.
8. Describe the role of the paramedic during a hazardous materials response.

**Course Requirements**

To earn a grade of “C” or higher the student must earn 70% of the total points for the course and meet all of the following course requirements.

- Pass the comprehensive final exam.
- Obtain certification in NIMS 100, 200, 700 and 800

- Complete the BPCCC Paramedic Student Minimum Competencies for this course.
- Must have a C or above to continue in the Paramedic Clinical Program

### **Course Grading Scale:**

- A- 90% or more of all possible points and meet the Course Requirements.
- B- 80% or more of all possible points and meet the Course Requirements
- C- 70% or more of all possible points and meet the Course Requirements
- D- 60% or more of all possible points and meet the Course Requirements
- F- less than 60% of all possible points or fail to meet the Course Requirements
