## **Course Description**

This clinical course allows the student to apply evidenced-based knowledge in the clinical setting. Opportunities to apply new clinical skills with regard to cultural and life-span diversity using hands-on and simulation technology are provided. Students will perform higher level critical decision-making and demonstrate professional behaviors including delegation, therapeutic communication, and leadership skills. Practicum hours focus on communication, disease processes, critical thinking, clinical skills, safety in the clinical environment, and utilization of the nursing process with an interdisciplinary team approach to manage care of adults in a medical surgical setting.135 contact hours of clinical experience.

Course Requirements In order to receive a grade of "C" the student must earn 76% of the total possible points for the courses and achieve <u>all</u> of the course requirements listed below.

The student will:

- Successful completion of IV skills check-off prior to beginning clinical rotations.
- Successful demonstration of physical assessment skills during the first week/weekend of clinical.
- Complete minimum of 135 hours of clinical/simulation time as assigned by faculty.
- Participate in all clinical assignments (written or direct patient care) as assigned by faculty.
- Earn a minimum grade of "C" on the Clinical Performance Evaluation Tool for each Medical- Surgical rotation and Simulation regardless of the combined weighted grade.
