**Course Prefix and Number:** PHAR 151

**Credit Hours:** 7 hours

**Course Title:** Pharmacy Clinical Practice

**Course Prerequisites:** Students must have successfully completed, with a grade of “C” or higher, in all PHAR courses, qualification coursework, and meet all other program requirements.

**Course Description:**

This course is designed for the PTEC clinical student who has successfully completed the didactic, lab, certification portion of the PTEC program. Students are assigned to at least two different types of experiential training sites and work under the supervision of a Louisiana licensed pharmacist, for a minimum of 400 hours.

**Learning Outcomes:**

At the end of this course, the student will be able to demonstrate:

- A. The ability to utilize personal and interpersonal skills and knowledge appropriate to the role of the pharmacy technician.
- B. The foundational knowledge and skills necessary to function as a pharmacy technician in two different pharmacy settings.
- C. Skills and knowledge necessary to assist the pharmacist in the correct handling of medication and medication order processing.
- D. Application of patient care, quality and safety knowledge and skills to the safe operation of a pharmacy.
- E. Compliance with regulatory issues in the operation of a pharmacy.

To achieve the learning outcomes, the student will:

- 1. Earn a minimum score of 3.0 on the experiential site grading form for each clinical site. (A, B, C, D, E)
- 2. Complete of a minimum of 200 non-paid clinical/experiential hours in two different pharmacy settings. (B, C)
- 3. Complete of all assignments with a minimum score of 70% on each. (A, B, C, D, E)
- 4. Submit of all required paperwork by the established deadline (E)
- 5. Complete end of program surveys (E)
- 6. Demonstrate compliance with all Pharmacy Technician program and clinical site requirements. (E)

**Course Requirements:** To earn a grade of “C” or higher the student must earn 70% of the total points for the course and meet **all** the following course requirements listed above.

**Course Grading Scale:**

- A- 90% or more of total possible points and meet all courses requirements
- B- 80% or more of total possible points and meet all course requirements
- C- 70% or more of total possible points and meet all courses requirements
- D.- 60% or more of the total possible points and meet all course requirements.
- F. - less than 50% of the total possible points or failure to meet all course requirements.
