Course Description:

This course provides an overview of fire protection and emergency services; career opportunities in fire protection and related fields; culture and history of emergency services; fire loss analysis; organization and function of public and private fire protection services; fire departments as part of local government; laws and regulations affecting the fire service; fire service nomenclature; specific fire protection functions; basic fire chemistry and physics; introduction to fire protection systems; introduction to fire strategy and tactics; life safety initiatives.

Learning Outcomes:

At the end of the course, the student will be able to

- A. Illustrate the history of fire service
- B. Utilize critical thinking skills to compare the components and development of the fire and emergency services.
- C. Utilize computer literacy skills to analyze careers in fire and emergency services
- D. Examine the main factors that lead to the spread of fire behavior through effective critical thinking and mathematical skills.

- 1. Illustrate and explain the history of fire service. (A)
- 2. Evaluate the culture of fire service. (A)
- 3. Analyze the basic components of fire as a chemical chain reaction, as well as the major phases of fire. (A)
- 4. Examine the main factors that influence fire spread and fire behavior. (A)
- 5. List and describe the major organizations that provide emergency response service and illustrate how they interrelate. (B)

- 6. Explain the scope, purpose, and organizational structure of fire and emergency services. (B)
- 7. Differentiate between fire service training and education. (B)
- 8. Explain the value of higher education to the professionalization of the fire service. (B)
- 9. Define the role of national, state, and local support organizations in fire and emergency services. (B)
- 10. Describe the common types of fire and emergency service facilities, equipment, and apparatus. (B)
- 11. Compare and contrast effective management concepts for various emergency situations. (B)
- 12. Identify fire protection and emergency service careers in public and private sector. (C)
- 13. Explain the primary responsibilities of fire prevention personnel, including code enforcement, public information, and public and private protection systems. (C)
- 14. Develop the components of career preparation and goal setting. (C)
- 15. Demonstrate the importance of wellness and fitness as it relates to emergency services. (C)
