Course Description: Instruction in budgeting, credit, investment, insurance, real estate, and other areas of money management. A study of the methods of financing, including sources and applications of funds, net worth statement analysis, financial planning, cash flow statement analysis, stocks, bonds, mutual funds, time value of money, and basic risk analysis.

Learning Outcomes:

- A. At the end of this course, the course, students will:
- B. Demonstrate the ability to understand the financial terminology and concepts that will enable an entrepreneur to be successful. Statements which flow from the accounting process with an emphasis on the balance sheet and the income statement;
- C. Understand financial statements, budgeting and working capital management;
- D. Develop an understanding of how business organizations operate and be aware of the events which have a financial impact upon them;
- E. Understand the time value of money concepts;
- F. Contribute toward BPCC's commitment to information technology by requiring students to use the Internet, e-mail, word processing software and spreadsheet software where appropriate within the course.

To achieve the learning outcomes, the student will

1. The student will have adequate knowledge to understand the overall workings of financial management from an entrepreneurial perspective, Financial Statement Analysis, Cash Flow, Time Value of Money, Asset Management, Financial Leverage, Capital Budgeting Techniques) through the use of peer-review financial articles, use of technology, and capital budgeting techniques (C,D,E);
2. The student will be able to apply financial reasoning and understanding to everyday ethical decision-making (B,D);
3. The student will be able to engage in competent written debate regarding entrepreneurial issues (A,B,E);
4. The student will be able to write cogent prose explaining issues regarding financial decision making for entrepreneurs (A);

Course Requirements:

- To pass the course, student must achieve a course average of 70% or above.
