**Credit hours:** 3

**Course Title:** State and Local Government

**Course Prerequisites:** None

**Textbook(s):** Bowman and Kearney. *State and Local Government*. Cengage. (For the exact textbook requirement, please refer to your instructor's course information syllabus.)

**Course Description:** Principles of state and municipal organizations and administration with emphasis on government of Louisiana.

**Learning Outcomes:**

At the end of the course, the student will:

- A. demonstrate knowledge of the new directions for state & local governments, concepts of federalism & the states, state constitutions, citizen participation and elections, political parties-interest groups & campaigns, state legislatures, governors, state bureaucracy (public administration), and the judiciary;
- B. analyze current political issues related to state-local relations, local government: structure and leadership and taxing & spending;
- C. examine and explain basic unique governmental aspects associated with state and local governmental operations in Louisiana not covered in the text (police jury system, utilization of parish versus county territorial governance structure, and the fiscal/general session Louisiana Legislative calendar).

To achieve the learning outcomes, the student will:

- 1. explain the power and responsibilities of subnational governments in the federal structure; (A) (C)
- 2. identify major features of state constitutions and explain the historical development of those documents, with specific attention to Louisiana and its state and local government; (A) (C)
- 3. distinguish between various forms of local government for counties, parishes and municipalities with specific attention to Louisiana and its state and local government; (B) (C)
- 4. explain the major structures and processes of state government including the legislative, executive, judiciary and bureaucracy with specific attention to Louisiana and its state and local governments; (A) (B) (C)
- 5. explain examples of policies addressed by state and local governments and the difficulties of implementing those policies, with specific attention to Louisiana; (B) (C)

6. explain the role of interest groups and political parties in American subnational governments with specific attention to Louisiana. (A) (B) (C)
