**Credit Hours:** 3-3-0

**Course Title:** Production and Recovery I

**Course Prerequisite:** MATH 102 and OGPT 131

**Course Prerequisite or Corequisite:** ENGL 101

**Textbook(s):** Material covered will be taken from various sources including, but not restricted to: various textbooks, articles, public records, and instructor's company non-confidential job files.

**Course Description:** The course encompasses well production operations from exploration until the well is abandoned. Primary focus is on reservoir characteristics and relation to well completions, workovers, and stimulation, which are key and critical to producing operations.

**Learning Outcomes:**

At the end of the course, the student will:

- A. understand geologic conditions relevant to oil and gas production;
- B. understand hydrocarbon reservoir considerations;
- C. evaluate hydrocarbon reserves using geological and engineering data;
- D. understand the importance of logging, coring, and testing; and
- E. understand how to retrieve well information from State Oil and Gas databases.
