Course Description: This course provides an introduction of the early childhood profession and is the foundation course for the Associate of Applied Science Degree in Care and Development of Young Children (CDYC). Information introduced in this course includes theories related to early childhood development and learning, ethical standards, types of programs and career opportunities. This course is designed to promote personal and professional insight.

- E. explore the various local and national early childhood organizations and develop a strategy to establish a career in of the early childhood profession;
- F. advocate for quality care and education for young children and their families.

- 4. Describe developmentally appropriate learning experiences for young children age birth to 8 years that promotes physical, cognitive, and creative development; (C)
