Course Title: Construction Contracting and Laws

Prerequisite: CONS 100

Textbook(s): Smith, Currie and Hancock. <u>Common Sense Construction Law: Practical Guide</u> for the Construction Professional, 5th Edition. Wiley Publishers, 2014. ISBN: 9781118858103.

Course Description: Contractual obligations for construction project delivery, contract hierarchies, and contract types will be examined. Bid systems will be covered. Common case law holdings and industry customs are reviewed. Regulatory issues—such as codes, code compliance, zoning and inspections—are explained. Red flag issues are explored.

- B. describe construction contracts and the reasons they must be carefully crafted and followed;
- C. apply the requirements for bonds and insurance contracts;
- D. work within the parameters of workers' rights, labor and employment agreements; and

- 16. simulate resolving potential conflicts. (E)
