**Course Description:** A course for industrial trade apprentices and drafters who need expertise in interpreting industrial blueprints, the 'graphic language' of industry. Emphasis is placed on blueprints as related to an industrial setting, symbolism, terminology, notes, material specifications and requirements, and sketching.

- B. identify and interpret line types, abbreviations, symbols, and information found on different types of prints;
