Course Description:

This course introduces students to the basic concepts and skills that are essential to the foundation of professional nursing practice. Included are therapeutic communication, QSEN competencies, the Nurse Practice Act, quality improvement, patient-centered care with regard to cultural and lifespan diversity, evidence-based practice, and the nursing process. Students learn how to meet basic human needs including physical assessment, medication administration, nutrition, elimination, and hygiene, while promoting safety among patients and staff.

Student Learning Outcomes (SLO)

1. Professional behaviors including commitment to continued quality improvement, ethical and legal standards of practice, efficient management of resources, patient advocacy and lifelong learning
2. Promote safety in the workplace to minimize risk of harm to self, patients, family members and coworkers.
3. Use of therapeutic communication techniques which result in optimal relationships with patients and families and teamwork and collaboration with interdisciplinary team members.
4. The ability to provide patient-centered care with regard to cultural and life-span diversity in a variety of healthcare settings
5. Evidence-based practice to inform the nursing process for clinical judgment and critical decision making.
6. Use of informatics and technology to document, manage patient records and support decision making.
7. Competency with the nursing process to assess, plan, implement and modify patient care to promote positive outcomes.

76. Discuss nursing skills such as catheter insertion and care, tracheostomy care, nasogastric tube placement, medication administration, and tube feedings. (CLSO: D, E)
77. Describe nursing measures to ensure a patent airway. (CLSO: D, E)

Course Requirements

In order to receive a grade of “C” the student must earn 76% of the total possible points on the unit tests for the course and achieve all of the course requirements listed below.

The student will:

- Participate in/complete all classroom/laboratory experiences (such as discussion questions; quizzes; case studies; concept mapping; DVD, video, web-site, or reading assignments).
- Be held responsible for the content of the entire course. The final exam is mandatory, will be cumulative, and worth 25% of the overall grade for the course.
- Be required to achieve a minimum overall average of 76% on tests throughout the course and a minimum score of 68% on the final exam to receive credit for this course.
- Earn a minimum score of 80% on the Nurse Practice Act and QSEN assessments.
- Complete a comprehensive assessment examination through ATI.
