**Course Title:** ICD-10-CM Coding

**Course Prerequisites:** Knowledge of ICD-9-CM and permission of the Department

**Textbooks:** AAPC's ICD-10-CM Proficiency Assessment Workbook and ICD-10-CM coding book, current edition

**Course Description:**

This course provides instruction in the latest edition of ICD-10-CM coding and classification system for outpatient facilities and/or physician services to assign valid diagnostic codes.

**Learning Outcomes:**

At the end of this course, the student will

- A. demonstrate the process of accurately selecting and assigning codes using the ICD-10-CM coding rules and regulations.

To achieve the learning outcomes, the student will

1. correctly identify first listed diagnosis codes. (A)
2. demonstrate the appropriate use of Y codes and Z codes. (A)
3. utilize knowledge of anatomy and physiology, pathophysiology, pharmacology and diagnostic procedures to correctly assign codes. (A)
4. utilize the ICD Coding and Reporting Guidelines to assign and sequence correct diagnosis codes for outpatient services. (A)
5. verbalize and demonstrate ethical coding principles. (A)
6. explain when it is necessary to consult with immediate supervisor or physician to clarify information in the medical record for coding purposes. (A)
7. demonstrate when it is appropriate to exclude diagnoses, conditions or problems when coding. (A)
8. verbalize the purpose of ICD-10-CM, the differences between ICD-9-CM and ICD-10-CM and the process required for implementation of ICD-10-CM. (A)
9. identify the medical record as the source document for all coding, list the medical reports important to the coding process and describe the steps taken to review a medical record for coding. (A)
10. complete coding exercises using the ICD-10-CM coding system. (A)
11. abstract diagnoses from case studies. (A)

**Course Requirements:** To earn a grade of "P" the student must meet all of the following course requirements.

- minimum average score of 70% on tests
- minimum average score of 70% on case study reports
