Course Title: Principles of Fire and Emergency Services Safety & Survival

#### **Course Description**:

This course introduces the basic principles and history related to the national firefighter life safety initiatives, focusing on the need for cultural and behavior change throughout the fire-emergency services profession. This course will be 100% presented in the "online" learning management system (Canvas)

## **Learning Outcomes:**

### At the end of the course, the student will be able to

- A. Identify and explain the 16 life safety initiatives through effective oral communication and computer literacy skills.
- B. Utilize research and written communication skills in order to understand the concepts of risk management and mitigation as it pertains to emergency services

### To achieve the learning outcomes, the student will be able to:

- 1. Define and describe the need for cultural and behavioral change within the emergency services relating to safety, incorporating leadership, supervision, accountability, and personal responsibility. (A,B)
- 2. Explain the need for enhancements of personal and organizational accountability for health and safety. (A,B)
- 3. Define how the concepts of risk management affect strategic and tactical decision-making. (B)
- 4. Describe and evaluate circumstances that might constitute an unsafe act. (A)
- 5. Explain the concept of empowering all emergency services personnel to stop unsafe acts. (A,B)

- 6. Validate the need for national training standards as they correlate to professional development inclusive of qualifications, certifications, and re-certifications. (B)
- 7. Defend the need for annual medical evaluations and the establishment of physical fitness criterial for emergency services personnel throughout their careers. (A)
- 8. Explain the vital role of local departments in national research and data collection systems. (B)
- 9. Illustrate how technological advancements can produce higher levels of emergency services safety and survival. (A,B)
- 10. Explain the importance of investigating all near-misses, injuries, and fatalities. (A,B)
- 11. Discuss how incorporating the lessons learned from investigations can support cultural change throughout the emergency services. (A,B)
- 12. Describe how obtaining grants can support safety and survival initiatives. (B)
- 13. Formulate an awareness of how adopting standardized policies for responding to emergency scenes can minimize near-misses, injures, and deaths. (A,B)
- 14. Explain how the increase in violent incidents impacts safety for emergency services personnel when responding to emergency scenes. (A,B)
- 15. Recognize the need for counseling and psychological support for emergency services personnel and their families and identify access to local resources and services. (A,B)
- 16. Describe the importance of public education as a critical component of life safety programs. (A,B)
- 17. Discuss the importance of fire sprinklers and code enforcement. (B)
- 18. Explain the importance of safety in the design of apparatus and equipment. (B)

- 1. The student must successfully complete the course with an average of 70% or above on the combined learning outcomes.
