## MEMORANDUM OF UNDERSTANDING BETWEEN LOUISIANA STATE UNIVERSITY AT ALEXANDRIA AND BOSSIER PARISH COMMUNITY COLLEGE

This Memorandum of Understanding is entered between Louisiana State University at Alexandria (LSUA) and Bossier Parish Community College (BPCC) for the program between the two institutions listed below:

BPCC	LSUA
Associate of Science in Nursing (RN-ASN)	Bachelor of Science in Nursing (RN-BSN)

BPCC has established associate degree programs and LSUA has established baccalaureate degree programs. Both institutions are accredited by the Southern Association of Colleges and Schools Commission on Colleges. This agreement will allow students completing the Associate of Science in Nursing degree at BPCC to complete the related bachelor degree program at LSUA. All credit hours as designated in Appendix A will transfer from BPCC to LSUA and will count toward the bachelor's degree. LSUA and BPCC mutually agree to:

Admission and Graduation Requirements

- A. LSUA admission requirements apply to students who transfer under this agreement.
- B. Students must fulfill graduation requirements at both institutions.
- C. Students must complete the selected associate degree at BPCC and meet the LSUA bachelor's program admission requirements for the agreement to apply.

Transfer of Credits

- A. LSUA will accept all credits used to fulfill the associate degree along with any additional hours of general education courses needed for the bachelor's degree from BPCC.
- B. Twenty-five percent of any bachelor's degree requirements must be completed through the LSUA program in order for LSUA to confer the degree.

Implementation and Review

- A. The Chief Academic Officers or designees of LSUA and BPCC will implement the terms of this agreement, including identifying and incorporating any changes into subsequent agreements; assuring compliance with system policy, procedure and guidelines; and conducting a periodic review of this agreement.
- B. The Memorandum of Understanding is effective on August 11, 2017 and will remain in effect unless terminated or amended by either party with 90 days prior written notice.

\* Upon graduation from the BPCC ASN program graduates will receive Block credit for their nursing courses.

\*\* BPCC nursing students interested in transitioning to the LSUA online RN-BSN program should be advised to take the following courses while enrolled at BPCC: CMST 1061 or 2060, CHEM 1001, and General Education Humanities Electives (6 hours) while enrolled at BPCC. Completion of these courses at BPCC will provide students the opportunity to transition directly into upper level RN-BSN courses.

## **Articulation Plan**

C. BPCC and LSUA will work with students to resolve the transfer of courses should changes to either program occur while the agreement is in effect.

LSUA agrees to:

- A. Accept BPCC credit as listed in Appendix A of the Memorandum of Understanding between LSUA and BPCC.
- B. Provide information about the agreement to BPCC advisors.
- C. Jointly market the agreement with BPCC.
- D. Communicate any and all degree program changes to BPCC.

BPCC agrees to:

- A. Provide academic advising to students who plan to transfer to a baccalaureate program at LSUA according to the agreements in Appendix A.
- B. Jointly market the agreement with LSUA.
- C. Communicate any and all degree program changes to LSUA.

Both parties will share assessment data and meet periodically to discuss the results.
